


Rules for submission of an electronic application form on registration of goods containing objects of intellectual property rights

Box 1 – Information about the applicant:


In this box, applicant's name (in case the applicant is a legal entity, his/her name, in the case of an individual, his/her surname, first name and patronymic), TIN or FIN code, legal or actual address, telephone number, e-mail address, and status of the applicant should be marked.


Box 2 – Information about the right holder:

In this box, the name of the right holder, registration address, affiliation of the right holder, address, telephone number and e-mail address should be marked.

Box 3 – Information about liaison persons:

In this box, information about the representatives (surname, first name, patronymic, address, telephone number and e-mail address) should be entered for solving legal and (or) technical issues on behalf of the applicant.







Box 4 – Information about rights:

In this box, information about the type of intellectual property and the type of document confirming the intellectual property rights (certificate, patent, license, etc.), as well as its number, date of registration and expiry date should be marked.

Box 5 – Information about goods:

In this box, the description of the goods, type, classification code (HS code), customs value, country of origin, kind of packages, number of items per package, border customs checkpoints used for the movement of goods, as well as information about the modes of transportation and the route of movement of the goods should be marked.

Box 6 – Useful information for detection the counterfeit and pirated goods:

In this box, the description of the suspected counterfeit and pirated goods, customs value, country of origin, kind of packages, number of items per package, border customs checkpoints used for the movement of suspected counterfeit or pirated goods, modes of transportation and movement route, as well as other useful information for identification purposes must be marked.

Box 7 – Information about the importer/exporter:

In this box, name of importer and (or) exporter, if any, the legal address, TIN, contact phone number, e-mail address, as well as information about the type of distributor (official, unofficial, exclusive, etc.) should be marked.
