Information on simple average, trade weighted average, 0% import customs duty rates and goods imported from FTA countries in 2022

- 1) The following parameters were used in calculating the trade weighted average tariff rate for 12 months of 2022:
- a) Amount of import operations for 12 months;
- b) Amount of collected import customs duties for 12 months.

Considering the amount of the import operations for 12 months being **14 539 858 500** USD (as the statistical value is expressed in US dollars), their total customs value for the mentioned period is **24 717 759 450** manats.

Customs value = 14 539 858 500* 1.7 manats = 24 717 759 450 manats

As the amount of import customs duties collected during 12 months is 1 419 968 700 manats, this figure represents 5.74% of the total customs value of imported goods (Table 1).
